Once a buyer for your current home is in place with a complete chain, you can proceed to a Full Reservation on your new home which can progress alongside the sale of your existing property.

What are the costs involved with the Moving with Homes by Carlton scheme?

The only upfront costs are a £150 reservation fee that will be deducted from the purchase price of your Homes by Carlton plot, and a non-refundable £30 Anti-Money Laundering (AML) check fee per person. For example, if there are two people purchasing the home, the total cost of the AML checks would be £60.

What do I have to do to qualify for the scheme?

All we ask is that you are qualified by our new-build mortgage specialists, who we will put you in touch with at the appropriate time. However, you're not obligated to use our panel of financial advisors to arrange your new mortgage.

Step 4

EPC*

It is a legal requirement for a property to have an EPC when marketing for sale. If required, we are happy to arrange this for you, however it will be payable.
